#### Sat., May 3 – CHICAGO / EN ROUTE

We depart Chicago's O'Hare International Airport early this afternoon by scheduled service of Lufthansa German Airlines on the overnight transatlantic flight to Frankfurt, Germany. (I)

#### Sun., May 4 – FRANKFURT / ATHENS

As the sun begins to rise on the German heartland we arrive in Frankfurt and change planes for the connecting flight to Athens, Greece. On arrival, we'll meet our Tour Guide who will accompany us on vacation. As we'll soon learn, Athens is the oldest capital of the modern world and is built around the Acropolis and the pinnacled crag of Mt. Lycabettus, which the goddess Athena was said to have dropped from the heavens to defend the city. **(I,D)** 

#### Mon., May 5 – ATHENS

Today's sightseeing tour of Athens will feature a visit to the Acropolis, the sacred hill of Athens and home to the ruins of the Parthenon, considered the world's most perfectly proportioned building. We'll also see the Propylaia, the Temple of the Wingless Victory, the Erectheum, as well as the Agora. Following our tour the afternoon is at leisure - an opportunity to explore Athens' rich cultural heritage that can be appreciated by visiting any one of its magnificent museums. You may also want to visit Athens' commercial triangle comprised of three main squares, Omonia, Syntagma and Monastiraki. The central shopping area lies between Omonia and Syntagma Squares and extends along Ermou Street on the way to historic Monastiraki, home to the famous flea market where the Athenian butchers often sleep on their marble slabs during the heat of the afternoon siesta. You'll also want to visit the Plaka, with its winding cobblestone streets lined with colorful houses and gardens. It is here where you'll discover the old-fashioned tavernas and antique shops while enjoying the atmosphere of a traditional neighborhood. (B)

#### Tuesday, May 6 – ATHENS / MYKONOS

Today we depart Athens and take to the skies on a short flight to the Cyclades Island of Mykonos. Although one of the smallest islands of the Cyclades, Mykonos is the most famous, thanks to its natural beauty, rich history, cosmopolitan character, and vivid nightlife. With an average of over 300 sunny days a year, it's an obvious utopian isle for travelers looking to indulge. As we'll soon learn, the secret's out - Mykonos is sophisticated and shiny, where bright white buildings pop against seriously blue waters and bougainvillea blooms. Alluring white sand beaches bathed in the bright sunlight of the Aegean by day and a sizzling St-Tropez-meets-Ibiza style stay-up-all-night spirit make the island a playground for wealthy. **(B,D)** 



#### Wed., May 7 – MYKONOS (Mykonos Town)

Once a quiet island known for its architecture and beautiful beaches, today Mykonos has become the home-away-from-home for many artists and fashion designers. White and glistening, scattered with windmills and over 1,200 churches, Mykonos is made up of flower-decked alleyways, chic boutiques, and picturesque fishing harbors. A morning walking tour of Mykonos Town will showcase its lifestyle, both past and present. Built in a maze of narrow lanes to defy the wind and to confuse attacking pirates, the bustling Old Port is one of the most photographed places in Greece. We'll see the Chapel of Saint Nicholas, dedicated to the patron saint of sailors, the Church of Panagia Paraportiani, and visit Little Venice. Unlike most buildings in Greece that utilize the bright, whitewashed Cycladic architecture, many of the homes in Little Venice are vibrant and colorful, and have adopted traditional Venetian architecture. Of course, no tour would be complete without stopping to get a picture of the famous Mykonos Windmills that can be seen from every point of the town. **(B)** 

#### Thursday, May 8 - MYKONOS / SANTORINI

Today we hop aboard a Hellenic Seaways high-speed ferry bound for Santorini, believed by many to be home of the lost city of Atlantis. With postcard images of whitewashed churches and bougainvilleaclad houses set against the blue sea and sky, this is a true island paradise. Santorini's spectacular caldera is a vestige of what was probably the biggest volcanic eruption in recorded history and is the reason for the island's crescent shape. The island's violent volcanic past is visible everywhere in black-sand beaches, earthquake damaged dwellings, and raw cliffs of lava plunging into the sea. **(B,D)** 

#### Fri., May 9 – SANTORINI (Oia, Megalochori Winery & Fira)

A tour of the island will begin with a visit to the village of Oia located on the rim of the Caldera, famous for its spectacular views and blue shuttered, white-washed houses with red pebble walls that cling to the cliff-face with the famous skafta cave houses and blue-domed churches. Next, we'll travel to the picturesque village of Megalochori, far removed from the tourist trail, boasting grand mansions, traditional architecture, pirate hideouts and vineyards - ideal for an opportunity to visit and get a taste of local wines and a lesson in the island's singular wine-making tradition. Afterward, we'll travel to Fira, the capital of the island and the biggest and most cosmopolitan settlement of Santorini. Fira is a combination of natural beauty, social life, and shopping. However, what makes Fira stunning is the Caldera view that leaves visitors speechless. (B)

#### Sat., May 10 – SANTORINI / NAFPLIO

This morning we depart Santorini and take to the skies on our return to Athens. On arrival, we'll travel along the seaside highway taking in scenic views of the Isles of the Sardonic Gulf while stopping to view the Corinth Canal, an artificial canal that connects the Gulf of Corinth in the Ionian Sea with the Saronic Gulf in the Aegean Sea. Then, we'll set our sights on the Argolid peninsula, where we'll spend our last two evenings in the seaside destination of Nafplio. One of Greece's most romantic cities, Nafplio brims with life, preserves its legends, and entices travelers with its mystical ambience. **(B,D)** 

#### Sun., May 11 – NAFPLIO (Neméa Winery)

This morning we'll enjoy a walking tour of Nafplio, considered the most elegant town of mainland Greece. We'll marvel at the ancient walls, medieval castles, Ottoman fountains and Venetian classical buildings all while learning about the Nafplio's long history. Our walk will take us along the delightful seafront promenade to Three Admirals' Square, dedicated to the admirals who beat the Turkish-Egyptian fleet in the Navarino naval battle in 1827, and through colorful Bougainvillea draped cobblestone streets to Syntagma Square, where the Venetian and neoclassical Parliament and the Archaeological Museum dominate.

This afternoon we travel towards the valleys and mountains surrounding the small village of Neméa. Renowned for its vineyards and exceptional wines, we'll visit one of the famous wineries predominantly featuring the native Agiorgitiko grape. A guided winery tour will introduce us to the production, grape collection, vinification, and bottling areas, as well as an impressive cellar. Afterward, we'll sit back, relax and enjoy a delightful tasting of the locally crafted wines. **(B)** 

#### Monday, May 12 - NAFPLIO / CHICAGO

This morning we return to Athens Airport to begin the return journey home. No better time to reflect on memories of our *Spectacular Greece* vacation to last a lifetime and celebrate the beginning of new friendships made along the way! **(B,I)**
