Sun., Apr. 27 - CHICAGO / EN ROUTE

Today we depart Chicago's O'Hare International Airport on our non-stop trans-Atlantic flight traveling to Dublin, Ireland. (I)


Mon., Apr. 28 - DUBLIN / KILKENNY

As the sun rises on the Irish coast we arrive in Dublin. Here we are met by our Irish Driver/Guide who will travel with us throughout the tour. Our day begins with a traditional Irish breakfast. Following breakfast we visit the home of equine royalty, the Irish National Stud. Established in 1946, the "National Stud" combines an active role in the development and promotion of Irish thoroughbred bloodstock. A tour of the grounds will allow us to see the next champions as they are being exercised, as well as explore the special foaling unit, and the farms forgery and saddlery, before stopping at the Horse Museum. Next we visit a local farm in the village of Ballybaught to see sheepdogs at work. A wonderful location where we experience a taste of pastoral life. In this relaxed atmosphere, the hard working sheepdogs will leave you feeling enchanted. See if you can whistle and command the dogs or simply sit back, relax and enjoy as Michael and his sheepdogs do their work with the sheep. This afternoon we continue to the medieval city of Kilkenny, one of Ireland's most cosmopolitan cities, a gem in the heart of Ireland's Ancient East and our hotel. Dinner is included this evening at our hotel. (B,D)

Tues, Apr. 29 - KILKENNY

Our walking tour of Kilkenny will introduce us to the Medieval past, hear about Kilkenny witch, Dame Alice Kyteler and Shee Alms House. We will meander through the famous Slip ways, Tholsel Story of Kilkenny Cats, Oliver Cromwell City Walls, and Gate Ghost Stories Churches, and all the Kilkenny characters of times past. Next we enter the peaceful grounds of Kilkenny Castle for a tour of this magnificently restored castle. Just opposite the Castle, be sure to take a peek into the Kilkenny Design Center, a well-curated shop featuring the work of Irish artisans. A visit to Kilkenny isn't complete without the Smithwick's Experience! Immerse yourself in the story of Smithwick's, told as only a local knows how. Where 300 years of history combine with extraordinary brewing innovations, to create the Smithwick's tour - an experience like no other. (B)





Wed., Apr. 30 - KILKENNY / KINSALE

We bid farewell to Kilkenny and drive to Ireland's southern coast to the port town of Cobh, the last stop for the Titanic before its doomed Atlantic crossing in 1912, where we'll visit the Cobh Heritage Centre tracing the history of emigration from Ireland to the United States. Next we discover the Heart and Soul of Irish whiskey at Midleton Distillery Experience. Home of seven iconic brands including Jameson. Midleton Distillery Experience is a one-of-a-kind whiskey experience that takes you beyond process and taste and brings you to the very essence of Irish whiskey. Taste, learn, shop, and take in the magic of Midleton. This afternoon we continue the delightful seaside town of Kinsale, and our hotel. Dinner is included this evening at our hotel. (B,D)

Thurs., May 1 - KINSALE

After breakfast we visit Charles Fort, on of Irelands largest military forts. A massive star-shaped structure of the late seventeenth century, well preserved despite its history. Charles Fort has been part of some of the most momentous events of Irish history. During the Williamite Wars, for example, it withstood a 13-day siege before it fell. Later, in the Civil War of the early 1920s, anti-Treaty forces on the retreat burned it out. Next we visit the 9/11 Memorial Gardens, set amidst rolling hills and lush green vistas stands a very special grove of trees in the quiet Irish countryside. Hedges crowd narrow roads and the wind swirls and whistles on the climb up the hill that leads to the Kinsale 9/11 Garden of Remembrance, commemorate the 343 Brave Firemen, who died so heroically in the line of duty at the Twin Towers Disaster on September 11th 2001 in New York. This afternoon, is at leisure to relax. An **optional** Kinsale's foodie tour will be made available. An engaging and experienced guide, will take us places that are off the usual food route where tastings are generous and the people lively. (B)

Fri., May 2 - KINSALE / KILLARNEY

Following breakfast we hear the story of Cork: its history, its people, colorful culture, wit and special traditions. Our local guide will take us on a tour of Cork where we will experience the scents and sounds of the English Market, stroll the busy lanes of the 18th century Huguenot Quarter and wonder at the magnificent French neo-gothic cathedral. Next we visit the fabled Blarney Castle. We'll have an opportunity to climb the steps of the fortress to see the world-famous Blarney Stone. Just a stone's throw away we'll also visit the Blarney Woolen Mills, the largest emporium of Irish crafts in the country where you can browse the finely woven Irish woolen products or relax at one of its welcoming pubs. This afternoon we drive into the Kingdom of Kerry and magical Killarney. Set in the scenic southwest, it is here where we'll find some of the most picturesque views in all of Ireland, along with incredible people, food, and pubs! Dinner is included at our hotel. (B,D)

Sat., May 3 - KILLARNEY (Dingle Peninsula)

After breakfast we drive via the town of Killorglin and out along the Dingle Peninsula. Our journey takes us along this scenic roadway, which winds along portions of the shoreline and through hilly countryside, enjoying spectacular views of mountains and coast, with new vistas opening up at every turn in the road. We stop in the lovely little town of Dingle before driving to the very tip of the peninsula along Slea Head Drive. We also see stunning Inch Beach. The beach stretches for 4 miles and is surrounded by beautiful, unspoiled scenery. On our return to Killarney we'll leave our motorcoach behind and enjoy a Jaunting Car ride filled with history, legend, and folklore. (B)

Sun., May 4 - KILLARNEY / DUBLIN

We depart Killarney and drive to the village of Adare village of Adare. Billed as Ireland's prettiest village, we'll have an opportunity to stroll along the town's Main Street of thatched houses, colorfully painted storefronts and beautiful gardens. This afternoon we make our way back to County Dublin and the capital city of Dublin. (B,D)

Mon., May 5 - DUBLIN

Today we set off with a local guide, who will show us around the prominent historic buildings and monuments of Dublin. The city has been molded through the centuries with many architectural styles, reflecting the economic, political, and artistic influences. We'll end our tour with a visit to the Guinness Storehouse to experience the Guinness Story and the brewing process before finishing with a sampling of their wonderful stout in the Visitors Bar. Following our tour, time at leisure will allow us to stroll pedestrian Grafton Street where you'll find plenty of shopping and Bewley's Café Theatre, a city landmark. (B)

Tues., May 6 - DUBLIN

Today is free in Dublin to explore the city on your own. Perhaps to visit one of the in Temple Bar for some wonderful music, to visit one of the many fabulous museums in Dublin, or stroll the grounds of Trinity College and experience the amazing Book of Kells. This

evening we enjoy a traditional Irish Pub Dinner - a night full of traditional Irish music, dancing, and entertainment! **(B,D)**

Wed., May 7 - DUBLIN / CHICAGO

All too soon, our Journey Through Ireland has come to its end. Transfer to Dublin Airport in plenty of time to check in for your flight. You may do some last minute shopping at the duty free stores before boarding your flight returning us to Chicago. Upon arrival at O'Hare we wish goodbye to the group for your own transportation to your home. (B,I)
