Day by Day Itinerary

Monday, September 1 – CHICAGO / EN ROUTE Tonight we depart Chicago's O'Hare International Airport on our Aer Lingus overnight transatlantic flight to Dublin, Ireland. (I)

Tuesday, September 2 – DUBLIN / DUNDALK

On arrival in Dublin our Driver/Guide, Patrick Foley, will welcome us to Ireland. Our day begins in the village of Slane where we'll enjoy a guided tour of Slane Castle, set in the middle of a 1,500 acre estate in the heart of the Boyne Valley. Next up, we'll enjoy a whiskey tasting at the Slane Irish Whiskey Distillery. Whether you're a seasoned connoisseur or simply looking to try something fun, it's sure to be an Irish experience to be savored. Afterward we'll travel to Dundalk, home to many generations of Paul Ward's family! (I,L,D)

Wednesday, September 3 – DUNDALK

This morning we'll head to the shores of the lough for a visit to Carlingford Oyster Company. The familyowned operation produces enough oysters to supply many top restaurants in Ireland and the United Kingdom, and the owner Kian Louet-Feisser, will show us the intriguing process of how the farm raises the luscious bivalves. Afterward, we'll head up the road a wee bit and allow time to explore Carlingford and have lunch in one of the many restaurants featuring fish n chips and, of course, oysters! Then, we'll embark on a ferry across Carlingford Lough as we make our way to the Killowen Distillery for a tour and tasting. Founded by distiller Brendan Carty, Killowen's team brings together a rogues gallery of whiskey experts and enthusiasts, all driven by one thing; bringing back the character and tradition of real Irish whiskey and Poitín. Seated in Poitín's ancient Mourne Mountains, Killowen uses traditional grains and a powerful mixed mash bill. (B)

Thursday, September 4 – DUNDALK

After a leisurely morning, we'll head out of the city to the beach! As we'll soon see, the Laytown Races occupy a unique position in the Irish racing calendar, as Ireland's only horse racing event run on a beach under the Rules of Racing. The Laytown Races first began in 1868, when races were run on the beach in conjunction with the celebrated Boyne Regatta. A rowing competition took place on the high tide and the horse racing began when the tide receded. Today, officials only have about three hours to assemble the track at Laytown, a process which can only begin when the tide has gone out. After the races, we'll find a bit of craic and a local restaurant for dinner. (B,D)

Friday, September 5 – DUNDALK / BELFAST

Today we depart Dundalk and travel to County

Armagh for the annual Armagh Food & Cider Festival. The festival takes place every September, in the heart of the Orchard County and is brimming with fine foods, foraged lunches, cider tasting, tours, talks and fiction amongst the apple-laden orchards. Leaving the festival, we'll stop at Long Meadow Cider where we'll enjoy an orchard walk and learn about the production process for their award winning products as well as a visit to the Apple Pressing and Bottling Room. We'll have time to relax in the new glass fronted Bramley Barn and enjoy a hot cuppa with delicious apple tart & fresh cream. And of course no visit with the McKeever Family would be complete without tasting their award winning craft ciders and apple juice. Afterward, we'll stop for a pint at historic McConville's pub in Gerard's hometown of Portadown. Our final journey today will bring us into Belfast, in County Antrim, and to our hotel for the next three evenings. Tonight, we'll enjoy dinner at the high end restaurant, Home, owned by Stevie Haller, an old friend of Ian's - he'll be sure that Stevie stops by to say hello! (B,D)

Saturday, September 6 – BELFAST

After breakfast, we'll head to Titanic Belfast, a fascinating and moving interactive experience. Explore the shipyard, walk the decks, travel to the depths of the ocean and uncover the true legend of Titanic in the city where it all began. Afterward, we'll be welcomed by our local guide for an unforgettable Belfast Food Tour where we'll see colorful street art, hear the history of the city, and of course, enjoy a wide range of local favorite bites. This evening, we'll join Billy Scott on our guided city tour; we'll see the raw side of Belfast and its colorful, often tragic, history, as we make our way up the Falls Road and down the Shankhill, the main Catholic and Protestant areas that were home to the bloody battle grounds. **(B,L)**



Sunday, September 7 – BELFAST

This morning we set out to visit St. George's Market. There has been a Friday market on the St. George's site since 1604 and the present, award-winning market, built between 1890 and 1896, is one of

Belfast's oldest attractions. Home to some of the finest fresh produce, as well as baked goods, crafts and more, the weekend St. George's Market has become one of the city's most popular places to visit. This afternoon we'll convene at a local pub to begin a pub crawl...stick with the guys for an unforgettable day of laughs, drinks, music and craic! (B)

Monday, September 8 – BELFAST / DUBLIN

After breakfast this morning, we'll bid farewell to Belfast for the drive to Dublin, the capital of the Republic of Ireland. Along the way, we'll stop at Sheridan's Cheese Mongers, where they sell farmhouse cheeses and specialty foods that are handmade in Ireland, as well as a wide selection of artisan foods from across Europe. Cheese in hand, we'll then set our sites on the Boann Distillery for a tour and a whiskey and food pairing. At Boann, every raw ingredient sourced is 100% natural and 100% local. Every drop of water is drawn from their Boyne Valley well, and every grain of barley is provided by native farmers. Next, we head into County Dublin, stopping at Butler's Chocolates. We'll be immersed in a magical world of chocolate artistry at Butlers, The Factory Tour. Visitors will be able to discover for themselves the process of how all the ingredients are combined together and transformed into luxury boxes of chocolates, chocolate bars, fudge, toffee and hot chocolate. We'll continue to our hotel where the remainder of the evening is at leisure. (B.L)



Tuesday, September 9 – DUBLIN

This morning, we'll visit EPIC: The Irish Emigration Museum where we'll discover the far-reaching influence of Irish history, and the impact the 10 million Irish men and women who left Ireland had on the world. We'll have lunch at nearby Urban, where the dishes are carefully crafted using only high-quality, locally sourced ingredients, offering a fresh and inventive twist to traditional Irish fare. This afternoon you'll have the choice to visit either Pearse Lyons Distillery, built in the beautifully restored Church of St. James in Dublin's historic Liberties, for a tour and whiskey tasting; or the

Guinness Storehouse, where exhibits on how this world-famous stout was first created and why it is so popular today, finishing in the rooftop bar, Gravity, overlooking the city center. Tonight we'll head to Taylor's Three Rock for an evening of sparkling Irish song, music, laughter and dance at Dublin's



World-Famous Irish Night & Cabaret. (B,L,D)


